


Hazard Mitigation Planning in Alaska



Program

Public Assistance (PA)

Individual Assistance (IA)

Fire Management Assistance Grant (FMAG)

- Deadlines are specific to the specific disaster declaration and timeline
- Eligibility may be restricted to entities in the declared area, defined by the jurisdiction, or State
